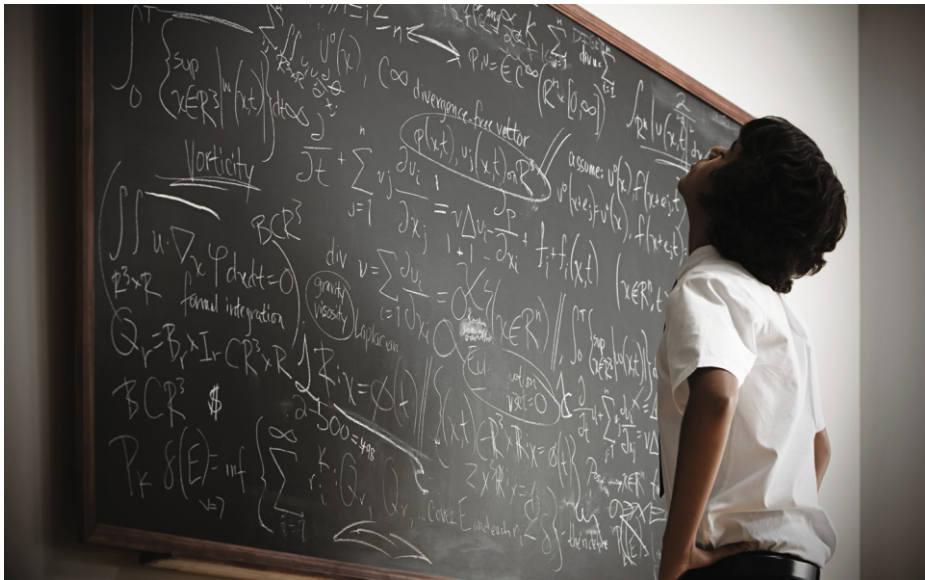

Program Benefits

- 1. Trust will pay 75% of the school fees for the student, subject to a maximum of Rs. 18,000 per year / 1,500 per month. Fee will be paid directly to the school on a quarterly basis.
- 2. Students who get 80% or higher marks (weighted average of all school-level exams held during the year) will receive an additional stipend of Rs. 3,000 per year for use towards their intellectual growth at the end of the school year.

Eligibility and application process

- 1. Students who are studying in a school located in MMR region (MMR) (including Mumbai, Thane, Mira Bhayandar, Kalyan Dombivali, Vasai-Virar, Navi Mumbai).
- 2. Families whose annual household income is less than Rs. 4,50,000 per annum/37,500 per month. (combined income of both parents / guardians) are eligible for the program.
- 3. Selection shall be made on basis of merit and financial need, as per the sole decision of the Governing body.
- 4. Over 1000 such scholarships shall be given each year of which 25% shall be earmarked towards families of government employees and preference shall be given to female students.
- 5. Only Indian nationals are eligible to apply for this program.
- 6. Students already availing of any other scholarship are not eligible for this program.
- 7. Decision on award will be notified by email or by phone for all students by 15th June 2015 (for those writing their 12th standard exam 15th July 2015)
- 8. To maintain eligibility for scholarship, students have to obtain min. 70% (B + Grade) in their school exams (weighted average of all school-level exams held during the year).
- 9. Only one child per family will be granted the scholarship.

How to Apply

- 1. Eligible students are required to fill the application form with complete details and submit it online or send filled up application form to the address mentioned above before the due date. Copy of mandatory documents must be attached if send by courier or post.
- 2. Students shortlisted may be asked for further details - attested photocopies of the originals documents such as academic certificates, mark sheets, etc., as and when required. These details will be informed via e-mail/letter.
